- ★ Member agrees to allow NGC, each month, to charge member’s credit card in the amount of said dues and to execute all additional documents necessary to authorize NGC to complete said monthly transactions during the full term of this agreement.
- ★ For and in valuable consideration of the payment of said dues, Member shall receive discounts for services provided by NGC as described on the schedule of services attached hereto and such other benefits which NGC may allow in the future.

- ★ Member acknowledges that he is aware of and agrees to fully comply with all the existing rules, requirements and regulations of NGC existing on the date of the execution of this agreement, and further agrees to comply with such additional rules, requirements or regulations for member as may be established in the future by NGC.
- ★ Safety is of paramount importance and Member acknowledges that he has read the safety rules of NGC, to which he agrees to fully comply.
- ★ Member agrees to at all times to exercise proper conduct while on the NGC premises.
- ★ NGC retains the right to terminate this agreement at anytime at the sole discretion of NGC, with or without cause, at which time all dues by Member will be prorated to the date of rescission of the agreement by NGC.
- ★ Member agrees to execute all exculpatory agreements and/or releases from liability, which NGC may require on the date of and in consideration of this membership agreement.
